Excises, customs and import duties accounted for 35 percent of Belize's revenue in . Belize's customs tariff is modeled from the Harmonized Description and Coding System (HS) and is based on the Caribbean Community's (CARICOM) Common External Tariff (CET). How are import duties calculated in Belize? Import duties on industrial products average at a rate of 20 percent but may be higher for products of national interest and protected for Belizean investment. Duties are calculated on the CIF Value of goods (Cost, Insurance, plus Freight).
