Why are Zambia's energy tariffs so high? Zambia's energy utility company charges one of the lowest tariffs in Southern Africa which has made energy investments very unattractive. Hiking electricity tariffs comes at a time when fuel prices have been hiked by around 10% compounding Zambia's economic challenges. Is Zambia's Electricity consumption outstripping its installed supply? According to the Zambia Development Agency, in the last three years electricity consumption in Zambia has exceeded its installed supply. In response to a power capacity deficit, Zambia has increased its electricity exports to neighboring countries, leading to rolling blackouts across the country.
